## 1. STRATEGY STATEMENT

This strategy sets out a series of core commitments which will be followed by HE providers within the Luminate Group. These commitments are in turn supported by a set of HE strategic principles.

## 2. POLICY AIMS/OBJECTIVES

This overarching strategy applies to the Higher Education provision offered at Leeds City College and Leeds Conservatoire. The Luminate Group HE Learning and Teaching strategy will be then delivered through individual group member Teaching, Learning and Assessment strategies.

The strategy's purpose is to ensure that all students are provided with an excellent learning experience whilst we respond to the changing context of learning, teaching and assessment. In addition, this HE Learning and Teaching Strategy is aligned with the requirements of awarding bodies the United Kingdom Professional Standards Framework (UKPSF), and the QAA Quality Code for Higher Education.
